Report on Business

The Issuer has operations in 4 states.

Florida:

In the State of Florida, the Issuer is a vertically integrated “seed to sale” company and is the first and largest fully licensed medical marijuana company. The Issuer cultivates and produces all of its products in-house and distributes those products to Trulieve branded stores (dispensaries) throughout the State of Florida, as well as directly to patients via home delivery. The Issuer operates approximately 686,008 square feet of total cultivation facilities, capable of producing 34,956 kg of product annually. Potencies range from 8.56% to 28.05% THCA on THC producing varieties and 8.07% to 15% CBDA on CBD producing varieties. The Issuer operates a GMP certified processing facility. The Issuer produces 224 different SKUs, including nasal sprays, capsules, concentrates, syringes, cannabis flower in tamper-proof containers for vaporizers (in compliance with Florida law), topical creams, tinctures and vape cartridges. The Issuer has 170,158 customers as of May 31, 2019, who average approximately 2 visits per month, and distributes its products to these customers in Trulieve branded retail stores or home delivery. The Issuer operated 28 stores throughout the State of Florida as of May 31, 2019, encompassing over 68,000 square feet of retail space. The Issuer operates a 68-vehicle delivery-service fleet. 8.9% of purchases are delivered. Ecommerce is expected to contribute 20% of Florida revenue in 2019.

California:

The Issuer also operates one store in California where it has 80% membership interest.

Massachusetts:

The Issuer has licenses for a cultivation facility, 3 medical and 3 adult dispensaries in the State of Massachusetts.

Connecticut:

The Issuer operates one medical marijuana dispensary in Connecticut.

Other:

Patients are further served by a Clearwater-based call center which received on average 3,400 calls per day.

The Issuer serves over 3,500 patients daily.

The Issuer engages with its consumer base via multiple social media platforms. As of May 31, 2019, the Issuer had 72,817 followers on Facebook, 21,295 followers on Instagram, and 6,030 followers on Twitter. 77% of the Issuer's customers had opted-in to receive emails, and 27% of the Issuer's customers had opted-in to receive texts.

2. Provide a general overview and discussion of the activities of management.

The Issuer was actively looking at various acquisition opportunities in other states and expansion plans for the business in the State of Florida. The Issuer acquired 80% of the membership interests of Leef Industries, LLC ("Leef Industries") in November 2018 and is waiting for approval from the State of California to complete the acquisition of the remaining 20% of the membership interests. The Issuer acquired 100% of the shares of The Healing Corner, Inc., a Connecticut corporation, in May 2019.

During the month, the Issuer was preparing for new dispensary openings in the State of Florida and was working on integration plans for its recent acquisitions in California, Massachusetts and Connecticut. Management also spent time working on strategic planning, integration plans and tactical execution plan for this year. Such plans include, among other things, a focus on inventory and shipment logistics for new dispensary openings, product quality and expansion of new product lines and effective branding and sales and marketing support.

The Issuer acquired 100% of the shares of The Healing Corner, Inc., a medical marijuana dispensary located in Bristol, Connecticut.

The Issuer entered into a contract to acquire 84.97 acres of land in Jefferson County, Florida which will be used to construct, on a phased basis, a 750,000 square foot indoor growing facility.

The Issuer acquired 11,610 new patients in May.
